
### Job Title: Business Intelligence Analyst


### The need


# Our work across the UK

### The role

Money Ready is seeking an innovative Business Intelligence Analyst to lead our data transformation journey. This is a newly created role offering the opportunity to shape how we leverage data for mission-driven impact. You'll be responsible for designing and implementing BI solutions that enable data-driven decision-making across the organisation, from programme delivery to board-level reporting.

This isn't a typical BI role with predefined projects and established processes. You'll have genuine ownership to shape Money Ready's data capabilities from the ground up. If you're excited by the prospect of building something meaningful, having real impact on an organisation's trajectory, and leading Money Ready to towards becoming a truly data-driven operation, this role offers that rare opportunity.

# Key responsibilities:

#### Dashboard & Report Development

- Extract, transform, and load data into BI systems
- Design and build self-service Power BI dashboards for internal teams across fundraising, opportunity management, income tracking, and program delivery
- Develop impact reporting solutions for external stakeholders including funders and partners
- Build reporting solutions that support board-level reporting with clear, actionable insights
- Create and develop solutions to track KPIs and progress towards organisational business plans, including recommendations on systems changes that enable effective internal reporting

#### Strategic Leadership & Collaboration

- Consult and collaborate with internal teams to understand their needs and translate business objectives into analytical requirements and reporting solutions
- Interpret complex data and communicate findings to diverse stakeholders in accessible language
- Independently lead BI projects from conception through delivery, managing multiple priorities and timelines effectively
- Act as the organisation's expert on BI reporting and analytics, advise and guide colleagues on BI reporting implementation
- Ensure data and reporting needs are represented in future projects
- Promote a culture of data-driven decision-making and drive continuous
  Improvement in how we collect, analyse, and use data

#### Data Quality & Governance

- Establish processes to monitor and improve data quality, including regular reports to highlight and address accuracy issues
- Partner with teams to investigate and resolve data issues, identifying whether they stem from process inefficiencies, training gaps, or system limitations
- Ensure data handling complies with data governance frameworks and legal requirements
- Apply advanced analytics to identify trends, opportunities, and areas for improvement
